1. PRODUCT DESCRIPTION

Phantom 3[™] is a two-component, hybrid polyurea elastomer spray system with a high poly content which is less sensitive to high humidity and moisture in the air or substrate. This product provides a flexible but extremely tough monolithic membrane with excellent water and chemical resistance, and it can be sprayed even in cold climates. Phantom 3 contains the maximum pigment load, ensuring a rich black finished product.

2. USES

Phantom 3^{TM} is designed for tank linings, primary and secondary containment, the manufacture of artificial rocks and boulders, industrial floor coatings, truck bed liners, and much more.

The value ranges stated in this Technical Data Sheet are based on system processing under laboratory conditions. Equipment configurations and/or field application conditions may produce variances in final system values.

5. APPLICATION REQUIREMENTS

Spray Equipment: Spray equipment must be designed to produce a minimum of 2000-psi with an output of 1.5 gallons per minute. The heating component of the equipment must be able to maintain a temperature at the gun of 140-145°F. The hose on the equipment must be heated and be rated a minimum of 3,000-psi burst pressure. The spray gun must also be rated at the pressures and throughputs required.

Substrate Parameters: The substrate must be dry! A minimum ambient temperature of 5 °F above the dew point is mandatory. The ambient relative humidity should not be above 85%. Product working temperature range is -40 °F - 280 °F. Pin-holing may occur if the above parameters are not strictly followed; it is up to the applicator to check initial climatic conditions. It is recommended that a small area be sprayed and checked for proper application.

Coverage: Phantom 3 theoretically will cover 1,604 square feet/100 gal drum set at 1 mil dry film thickness. Coverage of the substrate should include a waste factor based on conditions at the site and type of substrate to which the material is being applied.

6. STORAGE & SHELF LIFE

Liquid materials should be stored at temperatures between 55 °F and 95°F in sealed containers. The A-side component should always be blanketed with nitrogen gas. Material shelf-life is 6 to 12 months. Consult product SDS for proper safety and handling procedures of components.
